Approval of the 2011-11 Negotiated Agreement with the Kalida Education Association was tabled again this month pending receiving a signed copy of the agreement back from the KEA. A February 2nd meeting that was scheduled between the KEA and the board was cancelled by the KEA and the letter from the KEA cancelling the meeting was read to the board.

CRA TAX ABATEMENT APPROVAL WITH KAHLE SUPPLY AND FEED MILL 2011-021

Mr. Wehri seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

2011-2012 INTERNET SERVICE PROVIDER 2011-024

Mr. von der Embse motioned to Northwest Ohio Area Computer Service Cooperative (NOACSC) as our internet service provider for fiscal year 2011-2012 Mrs. Gerdeman seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

2010-2011 SPECIAL EDUCATION SERVICES CONTRACT

Mr. Wehri motioned to approve the revised amount of \$70,000 for special education services for the 2010-2011 school year that are provided by the Putnam County ESC. (Original estimate was \$97,000.) Mr Turnwald seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

2011-2012 SPECIAL EDUCATION SERVICES CONTRACT 2011-026

Mr. von der Embse motioned to approve a contract for special education services provided by the Putnam County ESC for the 2011-2012 school year at an estimated amount of \$70,000. Mrs. Gerdeman seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

2010-11 SCHOOL CALENDAR AMENDMENT 2011-027

Mr. Turnwald motioned to approve amending the 2010-2011 school calendar to remove February 21, 2011 (President's Day) as a makeup day. Mr. von der Embse seconded the motion and the roll being called upon for its adoption, all members were in favor. Vote unanimous. Motion carried.

At this time, Superintendent Horstman presented a list of budget cuts he will be recommending for approval at the March board meeting due to declining enrollment and financial reasons. After Mr. Horstman's explanation of and reasoning for the cuts, questions of those in attendance were answered. The lists of cuts up for recommendation are as follows:

- · Eliminate one bus route by eliminating in-town bussing
- Initiate a pay to participate program
- Move to all day, every other day kindergarten and eliminating the kindergarten bus route
- · Eliminate and/or reduce extended time/summer hours of classified and certified staff
- · Eliminate certain supplemental advisor, coaching and supervision positions
- Freeze salary index step for the Superintendent
- Eliminate the Elementary Physical Education teaching position
- Eliminate the School District Librarian position

Superintendent Horstman stressed that when the Governors Bi-Annual budget is released this March, there could be further cuts necessary to balance the budget.

EXECUTIVE SESSION 2011-028

Mrs. Gerdeman motioned to go into executive session at 9:40 p.m. to consider employment of an employee and to review negotiations. Mr. Turnwald seconded the motion and the roll being called upon for its adoption resulted as follows: Mr. von der Embse, yes; Mr. Turnwald, yes; Mrs. Gerdeman, yes; Mr. Wehri, yes; Mr. Laudick, yes. Vote unanimous. Motion carried.
