- The KES Christmas Program, "Christmas on Candy Cane Lane", was held Monday, December 12th for grades 1-3. Music and band students in grades 4-6 also participated. Thank you to Mrs. Schwieterman & Mr. Litwiller for their contributions.
- On Monday, December 12th the KES had one hour of PRIDE Time with the Houses. Students in each
 House met in a different location and worked with students across grades K-4 on several different
 activities. One of the activities was making Christmas cards for the nursing home, military, shut-ins, &
 1st responders.
- The Elementary joined in the joy of giving back by participating in a food drive and will donate to the food pantry in Ottawa.
- Kindergarten registration opened December 5th. Currently 39 students are registered for the 23-24 school year.

Discussions during Mr. Brinkman's High School Principal report (in Schoology):

- Mr. Clement, Mrs. Maag, Mrs. Smith and the middle school and high school student councils have
 once again done a fabulous job of getting our students involved in giving back to families in need

- Mr. Brinkman will be meeting with our senior Student Council members over lunch at Smoke-E's to
 discuss various topics about the culture and climate of KHS and what we can do to help improve the
 overall experience of our students.
- Mr. von der Embse asked Mr. Brinkman about the behavior of the students at the basketball games.
 Mr. Brinkman said he and Mrs. Stechschulte have been working with the student to make sure the students understand the behavior that is expected from them during the ball games.
