SCHOOL FINANCE AND HOUSE BILL 136 - The state of the economy is still a huge topic across the state and the country as we near the November 8 elections. The state of Ohio has gone through a very tough budget battle, and our state legislators have imposed a large number of cuts on state and local government entities and school districts. Kalida Local Schools has been able to continue reducing costs without cutting programs, and thanks to the help of our community and staff the district has been able to stabilize the budget for now. In the last six years we have reduced our teaching staff by eliminating nine and one half positions, and we have reduced our non-certified staff by eliminating four and one half positions. We have also reduced hours for other employees taking some of them from full time to part time status, and all district employees will also have their salaries reduced through the implementation and phase in of furlough days on calamity days. District employees will also see an increase in their insurance premiums phased in over the next three years. The Kalida Board of Education continues to strive to be fiscally responsible, and the district spends over \$1600 less per student than the state average. In spite of spending much less than the state average, our results are among the best of any district in the state.

Under the current state biennial budget, school districts are operating under a "Bridge" funding formula. This "Bridge" formula did reduce funding for most districts across the state, and is being used as Governor Kasich and the Ohio General Assembly develop a new school funding formula. The district will continue to monitor the development of a new funding formula and the effect it will have on Kalida Local Schools.

Another huge area of concern has been and continues to be a large number of federal and state unfunded mandates as well as legislation that seems designed to harm public education. These unfunded mandates and harmful pieces of legislation often require Kalida Local Schools to set aside or target funds to address problems we do not have. House Bill 136 (HB 136) is a prime example of a piece of legislation that seems designed to hurt public education. HB 136 would allow families making up to \$95,000 per year to apply for a voucher regardless of the academic standing of the public district the student currently attends. The original voucher program was designed to allow economically disadvantaged families in failing districts the opportunity to send their children to better schools. While the original program addressed a real problem, House Bill 136 attempts to fix a problem that does not exist. Under this new legislation families who are financially stable and reside in excellent districts would be able to siphon off tax dollars set aside to support local schools, and give those tax dollars to non-public/private schools.

House Bill 136 will greatly expand the current private school voucher program, and will send publicly voted tax dollars to private institutions. These school levies were passed in local school districts to support a specific school district, not to be sent to entities which may not even be located inside the local district. HB 136 also deducts the full amount of state and local funding from the local district regardless of the cost of tuition at the non-public school. In addition to this discrepancy, any tax dollars left in the students account can then be spent on college tuition later. Again, the tax dollars will not be spent in accordance with the wishes of the local community which voted to pass a levy to support their local public school district. The private schools which would receive the public tax dollars did not have to contribute to the cost of passing the levy which raised the funds, nor would they bear any of the cost of collecting these tax dollars.

In spite of assurances by Representative Wachtmann in a recent news article, this legislation does not spur competition or save the tax payers money. In order to have a true competition you need to have a level playing field, and the current rules are tilted dramatically in favor of non-public institutions. The schools receiving the vouchers through HB 136 are not required to follow the same rules public schools have to follow, such as requiring students to take and pass standardized state tests. Public schools educate all children, and are not able to turn away students based on economic status, ability, or the cost of required special programs. Public schools are also required to provide transportation and a host of other supplemental services to non-public schools. When all of these services are left out of the equation it is easy to see why Mr. Wachtmann thinks private schools are able to educate students for less money, but the truth is if private schools were required to follow all of the same rules as public schools the costs would be similar. I would encourage all of you to contact your state representatives, and ask them tough questions about their stance on school funding, unfunded mandates, and legislation such as HB 136.

RACE TO THE TOP

Kalida Local Schools continues to be a part of a national and state wide effort to improve education, instruction, professional development, and student assessment through the Race to the Top grant. As a part of the grant, Kalida Local Schools was required to form a Transformation Team of teachers and administrators. This team is tasked with developing a plan to implement new curriculum standards, improve student assessment practices, and a teacher evaluation tool. The Transformation Team will be attending the state Race to the Top Conference in Columbus on November 1st. The conference will be an opportunity for team members to participate in additional professional development and network with educators from across the state. The conference will also allow the team to research and identify successful practices from other districts which may be used to further enhance and improve academic practices in Kalida Local Schools.

Sewing up!

Throughout the four Biomedical Courses students become familiar with many biomedical laboratory techniques such as taking blood pressure, monitoring EKG's, DNA fingerprinting, and cancer screening just to name a few. They also have the opportunity to learn a few basic surgical techniques such as laparoscopic surgery and suturing. Therefore, Biomedical students spend many class periods cutting things up, dissecting hearts, kidneys, brains, eyes, and other organs. But as seniors they'll also learn how to "sew up" what's been

cut by learning basic suturing techniques. Students learn the techniques while watching a doctor demonstrate each type of suture. Students then practice the techniques on artificial skin and eventually are tested over the techniques by suturing lacerations on a pig leg. Later in the year, seniors will use their suturing skills to complete an autopsy. These classes will prepare the students for future classes in the medical field at college.

Guidance Notes ~ Jeff Clement

During the month of September and early October, I had the opportunity to visit all students in grades 6-12 in various classrooms to discuss a variety of topics. In addition, senior meetings have begun and will conclude by the end of October. In these meetings, their future plans are explored. All seniors and parents of seniors with plans of attending college after graduation are highly encouraged to contact their colleges of choice in October to pinpoint scholarships deadlines. Most colleges have specific deadlines – usually ranging from December 1 through February– by which students must apply for admission in order to be eligible for university relevant scholarships. Accessing a college's website or calling its financial aid office will help to verify these dates.

Scholarships - Now in October, scholarships sent to Kalida High School from local, state, and national organizations will begin to be made available to seniors. Most have specific criteria which a student must possess in order to apply. These scholarships will also be posted on the guidance link of the Kalida schools' website (www.Kalida.k12.oh.us) on a monthly basis. During October, various college representatives will continue to visit Kalida High School. All juniors and seniors have opportunities to talk to these individuals. One local college fair will take place in early November. This college fair is scheduled at the OSU-Lima/James A. Rhodes State College Campus in Cook Hall on Tuesday, November 1 from 6:30 – 8:00 pm. Over 100 schools will be on hand at these fairs to present material and answer questions. These college fairs are open to all students and parents with no charge for admission.

Sophomore Testing - All sophomores currently have had the opportunity to register for the PLAN or Pre-ACT. This is a good practice test for the ACT which students should take later in high school as preparation for college. The PLAN is a shorter version of the ACT and is a good indicator or predictor of how students will do on it. Approximately two months after the test date, which is Tuesday, November 15, an informational session will be held with students to discuss their score reports. The cost of the PLAN is \$11. A few extra tests were shipped with the order so please have your student stop by the guidance office if interested and has not yet registered. Exact cash or checks made payable to Kalida High School are the accepted forms of payment.

Project Northland - Beginning in early November, sixth and seventh grade students will begin lessons for the Project Northland curriculum. This curriculum is part of a research-based program that has been proven effective in delaying alcohol use and reducing alcohol-related problems among young people. Your support is one of the keys to its success. Representatives from all of the Putnam County schools approved this program and its use for the prevention of alcohol use at a young age.
