# Notes from Superintendent Don Horstman SCHOOL FINANCE

As we begin the new calendar year, we also enter into a difficult financial time for public schools in Ohio. It is a time of unknowns in terms of what public education might look like during the current school year and going forward. Ohio's annual budget is roughly \$50 billion dollars and the State of Ohio is currently facing a budget shortfall of between \$4 billion and \$8 billion. Governor-elect Kasich will unveil his plans for the next biennial budget in March, and Mr. Kasich and incoming House Speaker, Representative Batchelder have been very clear in their plan to reduce the state share of education funding. The following statements were made by an official with the Ohio School Boards Association who was recently quoted in the Columbus Dispatch:

"I think the education community is nervous about what's going to happen," said Damon Asbury from the Ohio School Board Association. Asbury said that the districts have been preparing for cuts that could total up to 20 percent in their next budget." These could be devastating cuts," Asbury said. "School districts will, with these kinds of cuts, there will be layoffs and programs cut."

The district and the state are dealing with the same issues that many of you are dealing with in your personal finances; falling incomes and increasing expenses. The Board of Education has been committed to saving jobs whenever possible while simultaneously reducing expenditures. As was stated in the October Paw Print over the last six years the district has reduced the teaching staff by eliminating seven positions and non-certified staff by eliminating three positions. The district has been forced to do this for two reasons, declining enrollment and falling revenues. I have included a chart showing the district enrollment that is reported to the state during our October count week. This chart includes the enrollment by grade level for every district in the county. The October count is a portion of the formula used to calculate our state funding. Over the last ten years Kalida Local Schools has had a decline in enrollment of more than 130 students, and a decline of 34 students since the 2008-09 school year. The entire county has had a decline of over 1200 students in the last ten years.

To this point the district has been able to reduce staffing through attrition. However, I am compelled to make it clear to all residents and employees that we are not in a financial position to absorb even a 10% (approximately \$260,000) reduction in state funding without making drastic reductions to programs, services and personnel. This problem is further complicated by the fact that we do not know how large the pending reductions will be. Once our schedules and staff are in place for the upcoming school year, it is very difficult to make staffing reductions. The school district has contractual obligations and state laws that dictate the timelines for notifying staff members who might potentially lose their positions.

When school districts are faced with a financial scenario like I have just described, there are really only two options to consider: reducing expenditures or increasing revenue. At this time, there are no plans to attempt a levy (our only means of increasing revenue). The Board of Education is fully aware of what our taxpayers have endured as a result of the economic downturn. 

# "Bully Proofing" Workshop for Parents

On February 3, 2011, from 6:00 PM until 7:30 PM. the Putnam County Educational Service Center will be hosting Mr. Jim Bisenius. The anti-bullying parent workshop will cover exactly how to teach your child to respond to verbal bullying, physical bullying, social bullying, and group manipulation. Parents will walk away with concrete tools that they can immediately

implement and help their child master in order to eliminate bullying from his or her life. Participants will learn specifically how "popular" bullies isolate, control and manipulate their peers. Then they will learn exactly what steps their son or daughter must take to stop them. In addition, parents will be able to use all of these techniques in their own life to deal with controlling or intimidating adults. It will be held in the assembly room at the Putnam County Educational Service Center located across from the Putnam County YMCA at 124 Putnam Parkway, Ottawa, Ohio.

Jim Bisenius has sixteen years of experience as a child and adolescent therapist specializing in teaching extremely targeted youth how to handle bullying situations. He has developed response techniques that have been recognized nationally as extremely effective at stopping the dance between kids who bully and the ones they target. Jim has taught his methods to over 450 schools nationally.
